GENERAL SHOW RULES

This show will be conducted under the official show rules of the latest edition of the American Rabbit Breeders Association and the rules as stated below. By submitting an entry, the exhibitor implies the acceptance of these rules:

1. This is a one (1) day carrying cage show to be held at the Egan's Home – 2509 Talisman Dr. - Bakersfield, CA 93304. Check-in starts at 7:30 A.M. and judging starts promptly at 8:30 A.M.
2. EAR CHANGES ONLY will be allowed at the table. Only ear changes in the same variety, breed and class as original rabbit/s entered in the show.
3. All rabbits must have permanent, LEGIBLE, ear mark in the animal's left ear. This rule will be STRICTLY enforced.
4. Exhibitors are responsible for getting their animals to and from the judging tables. No class will be re-judged due to late or missing animals, per ARBA Show Rules. No refunds will be given for missed classes for any reason. NO EXCEPTIONS!!!
5. All animals are entered at the owner's risk. Show personnel and judges are not responsible for injury or loss of animals. All precautions will be taken to prevent injury to all animals.
6. The show committee reserves the right to substitute or add judges as necessary.
7. Absolutely NO CATS OR DOGS allowed in the show room, except assisting guide dogs
8. Absolutely NO ALCOHOLIC BEVERAGES will be allowed on the property where the show is being held. NO EXCEPTIONS!!!
9. Showroom etiquette will be strictly enforced. Violators will suffer an elimination of their entries and forfeiture of their entire entry fee.
10. PARENTS OR GUARDIANS MUST CONTROL THEIR CHILDREN. You will be held responsible for any damage to the Egan's home, equipment & grounds. ABSOLUTELY NO SKATEBOARDS, ROLLERBLADES, BICYCLES OR SCOOTERS ON THE PROPERTY.
11. No sale of merchandise (other than rabbits) will be allowed on the grounds unless prior arrangements have been made for booth space. Booth space must be paid for in advance. Sale rabbits must fit in the space allotted for your entries.
12. It is the responsibility of the exhibitor to pick up remark cards when removing rabbits from the judging table. ALL awards MUST be picked up the day of the show, they WILL NOT be mailed. LEGS WILL BE MAILED WITH THE SHOW REPORT.
13. Judges decisions are FINAL. Entries may be withdrawn from competition by the committee and/or judges at their discretion, and entry fee forfeited, for interference with the judging process. Indicating ownership of an exhibit will be considered interference.
14. No one will be allowed behind the judging table without the permission of the table ramrod or clerk.
15. The KCRBA guarantees their own specials but cannot be responsible for individual specials or donations.
16. Failure to adhere to the above stated rules or those of the ARBA will be grounds for forfeiture of your entire entry.
17. Any discrepancies with the show rules listed here or those of the ARBA will be decided by the KCRBA Show Committee Officials and judgments made will be final.
