## **Entry Information:**

- \*All entry fees are \$5.00 for both shows or \$3.50 for a single show.
- \*Fur class is a \$1.00 per show.
- \*Payment must be sent with mailed entries. Make checks payable to..... HRRC.
- \*Emailed entries is your promise to pay. The email must include the following information: Exhibitor name, address, city, state and zip code; telephone number and email address; whether it's open or youth; breed, variety, sex and class of the rabbit/s; and whether it's a single show or double show.

- \* If you do NOT receive an email confirmation, your not entered. Double check!
- \* Please do not send cash. Collect calls will be made to all exhibitors with incomplete information. Ear changes can be made at judging table.
- ~Bad checks "You may be liable for up to three times the amount of the check, minimum charge of \$35.00 to cover expenses. If you fail to clear your bad check within 14 business days, you will be turned over to the DA for further action."
- \* If you enter via email, money is still due prior to the start of the show, even if you don't attend the shows.

## **Show Information and Rules:**

- ~ This is a one day carry cage show. ALL CAGES MUST BE WATERPROOF. Showroom opens at 7:00am and judging will begin at 8:30am.
- ~ Both shows will be governed by the latest rules of ARBA. Your entry indicates your acceptance of these rules.
- ~ All animals must be permanently and legibly earmarked in the left ear. (A) Rabbits not legibly earmarked must be disqualified from the class. Legibility of the earmark is at the discretion of the judge. This ruling also applies to rabbits with leg bands. In addition to a leg band they must also have a legible earmark in the left ear.
- ~ Show management must remove from the showroom all diseased or unsightly specimens and entry fees on such specimens will be forfeited. Any officer or member of the show committee will reinforce this rule.
- ~ Out of consideration of the judges, please trim your rabbits toenails prior to judging.
- ~ All rabbits are entered at the owners risk. Every precaution will be taken to safeguard and minimize hazards, losses and mistakes. Show personnel, judges and Hoppin' Rock Rabbit Club members are in no way responsible for the death or injury of any animal.
- ~ Exhibitors are responsible for getting their rabbits to and from the show table. Exceptions may be made for persons assisting with the show. There will be NO REJUDGING.
- ~ Parents must control their children or youth transported by them. Parents will be responsible for any damage to the premises or property of Chico State Farm made by their youth or the youth transported by them.
- ~ All legs will be mailed.
- ~ No grooming tables will be allowed between the aisles or where they restrict access to emergency exits.
- ~ The show committee reserves the right to add judges and/or make any substitutions.
- ~ A rabbit registrar will be available to register rabbits. You will need a current ARBA membership card, rabbit 6 months of age or older and senior weight for breed, pedigree and registration fee of \$6.00 per rabbit.

- \* There will be a silent auction between the hours of 8:30am to 1:00pm so remember to bring some extra cash so you can join the fun.
- \*Plus, we are always looking for donations to help offset costs, all donations gladly accepted.
