## Judges

**Mike Avesing, Iowa:** Mike has successfully raised many breeds including Satins, Holland Lops, Netherland Dwarfs, Mini Satins, and English Spots. He has served as a committee member for many years and chaired the ARBA Standards Committee. He has many times served as a nominated ARBA Convention Best In Show Judge. Currently, Mike is running for President of the ARBA.

**Wade Burkhalter, Missouri:** One of the most popular judges in the United States, Wade has raised nearly every breed of rabbit and has a great understanding of all body types. He has most experience with Mini Satins, Mini Rex, Netherland Dwarfs, Rhinelanders, Californians, Havanas, American Fuzzy Lops, Jersey Woolies, Lilacs, Polish, and Mini Lops. He has twice served as a nominated ARBA Convention Best In Show Judge.

**Scott Rodriguez, Colorado:** Scott is a recently licensed and up and coming judge. He raises nationally competitive Holland Lops and Netherland Dwarfs and is very passionate about his hobby. He is by profession an attorney, and currently serves as chair of the ARBA Constitution and Bylaws Committee.

**April Wright, Alaska:** April and her family have raised breeds such as Tans, Britannia Petites, and Polish in the distant and gorgeous state of Alaska. She is the current presenter of the Lilac Polish. She has attended many ARBA Conventions, and loves judging rabbits. Her Polish captured Best of Breed at the 2009 ARBA Convention in San Diego.

**Kevin Stanford, Arizona:** A fast up-and-coming judge, Kevin has experience breeding Netherland Dwarfs, Holland Lops, and Polish. He won several classes at the '09 Convention where he also judged Youth Netherland Dwarfs. He is a past President of the Southern Arizona Rabbit Breeders Association.

**Brad Boyce, Indiana:** Countless breeders try, but few accomplish Best In Show at an ARBA Convention; Brad and his wife Katie did just that at the 2002 ARBA Convention with a black Havana. Brad also has experience raising Netherland Dwarfs and Tans. He has served as a nominated ARBA Convention Best In Show Group Judge.

**Cheryl Blackman, Texas:** Cheryl has judged quite a bit since gaining her license several years ago, including youth Satins at the 2008 ARBA Convention. She is an active force behind the meat rabbits at the celebrated Houston Livestock Show, and raises the Satin breed. Cheryl is a science teacher, and a graduate of Texas A & M with a masters in Agricultural Development.

**Willis Plank, Michigan:** Rabbits are a family affair for Willis and his wife. They raise nationally competitive Champagnes, and even captured a Group win during Best In Show at a recent ARBA Convention. His wife Chris breeds competitive Holland Lops.

- West Coast Classic reserves the right to substitute judges as needed.
- Exhibitors will be responsible for getting their rabbits to and from the judging table. **There will be no re-judging due to late or missing animals, per ARBA Show Rules!**
- All animals must be healthy and in proper-sized transport cages to ensure the rabbits well-being.
- **All fees owed must be paid before the start of the show, or the West Coast Classic reserves the right to revoke your entries. All email entries must be paid in full upon arrival to the show. Should you not attend, you will still be billed for your entry.**

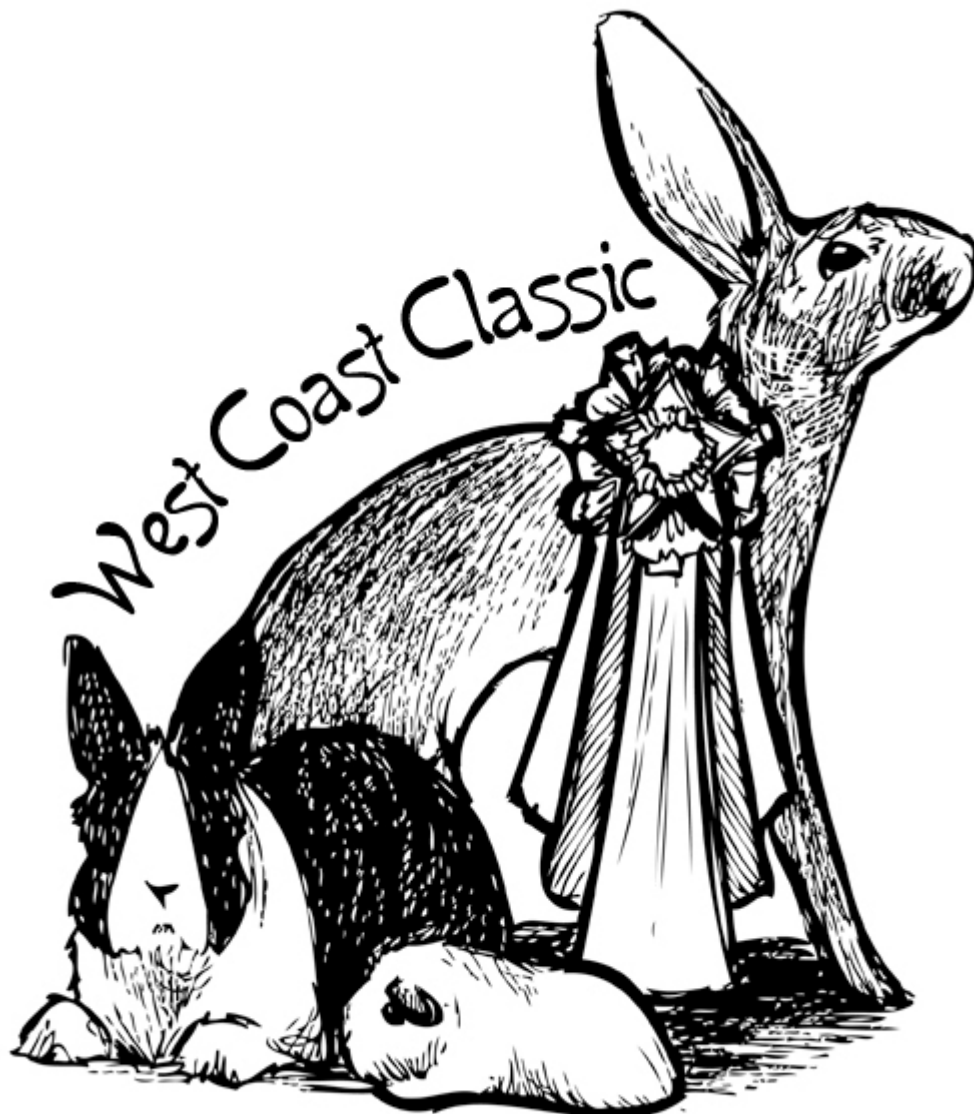
