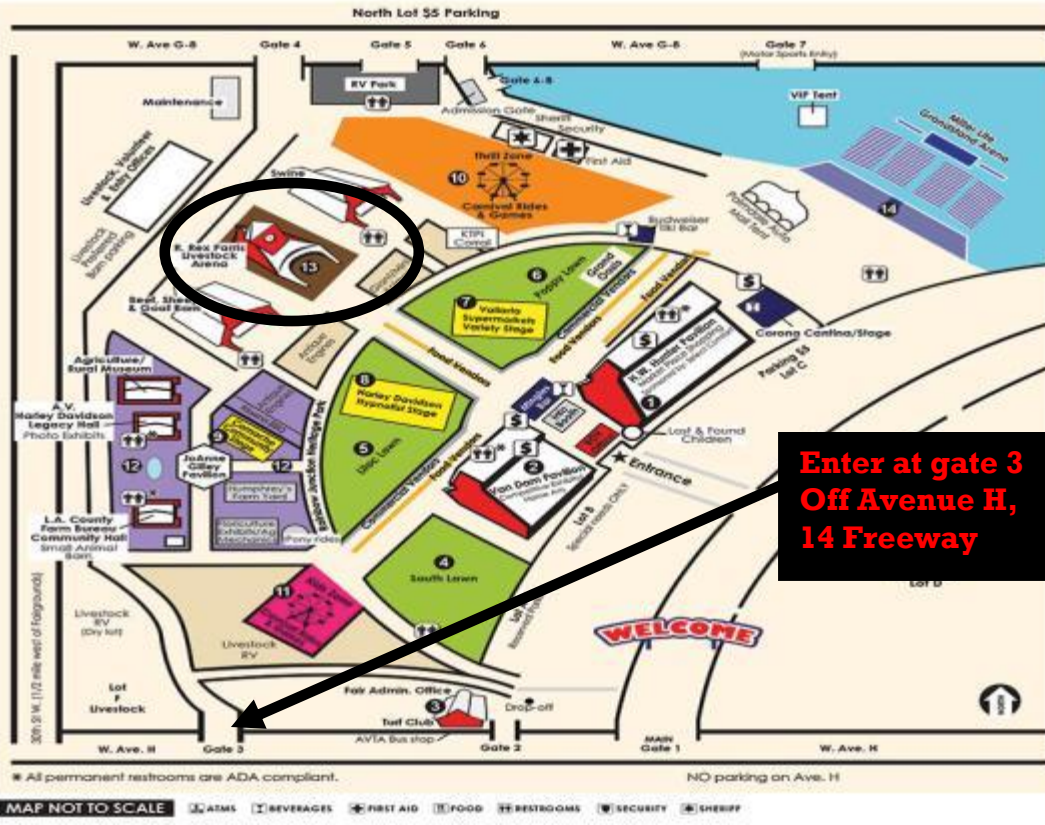

- If judges have reached their maximum day of show entries will not be accepted
- Entries must be paid before the show starts at 8:30 am
- There will be a \$5.00 charge for each additional animal entered in each open and/or specialty show. That is \$5.00 EACH for EACH Show.

OFFICIAL SHOW RULES

1. This show is held in strict accordance with the latest and revised Official Show Rules of the American Rabbits Breeders Assn. Inc. (ARBA)
2. Your entry indicates your acceptance of these rules.
3. Antelope Valley Rabbit and Cavy Club (AVRCCC) reserves the right to refuse any entry.
4. All rabbits are entered at the owner's risk.
5. While every precaution will be taken to safeguard and minimize hazards, losses, and mistakes during the event, the show personnel, judges, the Antelope Valley Rabbit and Cavy Club members, and/or the Antelope Valley Fairgrounds and/or employees are in no way responsible for damage, loss, or injury of any animal, person, guest, or property.
6. AVRCCC also reserves the right to add or change Judges at any time.
7. The show is a one-day carrying cage show. All cages must be leak-proof.
8. Unhealthy rabbits must be removed immediately from the showroom.
9. Showroom will be open at 7:30a.m. Judging will begin promptly at 8:30 a.m.
10. According to ARBA rules an exhibitor cannot make any comments which may identify ownership of a rabbit, nor may they attempt to influence the judging of an animal. Anyone doing this may have their animal disqualified, the exhibitor may be removed from the showroom, and all entry fees will be forfeited.
11. All rabbits must be permanently and legibly marked in the left ear.
12. Exhibitors are responsible for making sure their rabbits get to and from the judging tables. Be careful not to miss your class. There will be no rejudging of classes for missed rabbits.
13. Judging for Show B and specialty shows may start before Show A finishes.
14. There will be no refunds of exhibitor's fees after the close of entries.
15. *Should you enter by email, your entry is a contract between you and AVRCC, and fees are payable regardless of your attendance.*
16. Please be considerate when setting up your space, as we need to have room for all the rabbits and exhibitors. For safety, the aisles must be kept clear.
17. Exhibitors must clean their area when leaving; otherwise, a fine may be imposed. Keep your entry fees down by helping us keep a clean show facility. Please pick up your trash and debris!!!!
18. We are guests on the fairgrounds; please behave responsibly. Any inappropriate behavior, disrespect for animals, property, or persons will result in dismissal from this show and the forfeiture of all entry fees.
Parents and/or acting guardians will be responsible for the conduct of their children.
19. The only animals allowed in the showroom are rabbits and cavies (Exception – service animal under protection of the American Disabilities Act).
20. NO ANIMALS UNDER 6 WEEKS OF AGE ALLOWED IN THE SHOWROOM.
21. All legs will be mailed. Awards (trophies, ribbons, etc.) must be picked up the day of the show at the Awards table.
22. Youth may not enter the same animal in both Open and Youth, but they may enter different animals in Open and in Youth.
23. Judging assignments are not made until the day of show.
24. Any issue that arises that cannot be resolved by reference to these or ARBA rules shall be decided by the Official Show Committee. Their decision will be final.
25. Ear changes will be allowed at the judging table for the same sex, age, and variety at no charge for the first 4 rabbits or cavies. After the 4th animal there will be a charge of \$1.00 per rabbit or cavy per show. Changes to class, variety, and/or sex will NOT be permitted.
 - Unauthorized changes will be considered NO SHOWS. There will be no refunds or legs mailed.
 - For the 5th and additional changes, it is the exhibitors' responsibility to complete paperwork and PAY fees prior to the breed being judged.
